Our CREW Dallas By-Laws state that our membership composition must be at least 75% Full Members and no more than 25% Affiliate. We may suspend approving Affiliate Members from time to time if we exceed these percentages. Members must also meet the below description for current direct involvement as stated by our bylaws.

“Current direct involvement” means that the applicant (a) currently works in and is actively engaged either exclusively or primarily in commercial real estate (i.e., all or most of the applicant’s gainful employment or major source of income is in commercial real estate), and (b)(i) promotes and contributes to the financial well-being of the applicant’s company, (ii) holds a managerial, senior level, professional, principal, or revenue-generating position, (iii) is in a decision-making position, or (iv) otherwise participates at a professional level in one of the primary disciplines listed above. Persons who serve in a support capacity, a staff position, or an assistant/ministerial/secretarial position are not eligible for membership.

In addition, membership shall be open, at the discretion of the Board of Directors, to an applicant who (i) currently works in and is actively engaged either exclusively or primarily in commercial real estate (i.e., all or most of the applicant’s gainful employment or major source of income is in commercial real estate), (ii) promotes and contributes to the financial well-being of the applicant’s company, (iii) currently holds a position at a managerial, senior level, professional, principal or revenue-generating position, (iv) is in a decision-making position, or (v) otherwise participates at a professional level in one of the affiliate disciplines listed on page 3.

One (1) current CREW Dallas member sponsor is required for each application. If you do not know anyone in CREW Dallas, the Membership Committee can assign a sponsor to assist you.

Applications are to be submitted with an application processing fee of \$30.00. Make checks payable to CREW Dallas or call the office at 214-890-6490 to pay with credit card over the phone. Applicants can mail their applications to the below address or email the application to khopkins@crew-dallas.org. Annual dues for membership in CREW Dallas are \$495/year for Full members, \$275/year for Associate members (applicants with less than 5 years’ experience in commercial real estate), and \$2,000/year for Affiliate members. New members will be billed by CREW Network upon acceptance into the organization. The actual amount owed upon acceptance may vary based on when the applicant is approved for membership.
